REGIONAL SURVEY AND CERTIFICATION LETTER NO. 08-01

All Title XIX Single State Agencies (Action/Information)

SUBJECT: Procedures for Non-Long Term Care Facilities with Standard Level Deficiencies at the Initial Survey.

This Regional Survey and Certification (RS&C) letter supersedes RS&C letter 04-01.

In accordance with 42 CFR 489.13, if the provider had standard level deficiencies at the initial survey, state on the CMS 1539, Block 16, the date the Plan of Correction (PoC) was received and the date the PoC was approved by the state survey agency, the approving authority. **The effective date for Medicare participation is the day the PoC was received.** Therefore, page one of the CMS-2567 should be marked with the date of receipt, regardless of when the PoC was approved.

Also, have the first page of the CMS-2567 signed and dated by the approving authority. 42 CFR 489.13(c)(2)(ii) states in part:

"The date on which a provider or supplier is found to meet all conditions of participation or coverage, but has lower level deficiencies, and CMS or the State survey agency **receives** an acceptable plan of correction for the lower level deficiencies, or an approvable waiver request, or both. (The date of receipt is the effective date regardless of when CMS approves the plan of correction or the waiver request, or both.)"

These instructions also apply in instances when the PoC is received while the survey team is on site at the facility.
